### CYBERTRAPS FOR EDUCATORS 2.0

In 2015, I wrote a groundbreaking book on the risks teachers face from the use and misuse of digital devices and online services. This presentation, based on my recently-released update to that book, offers teachers practical and timely advice on how to minimize the latest risks. The program makes extensive use of my ongoing research on educator misconduct cases from around the world.

### POLITICS AND THE ETHICAL EDUCATOR

In an era of profound political polarization, teachers are under increasingly strict scrutiny by administrators, parents, activists, and politicians for how they conduct themselves online. Thanks to the powerful combination of mobile devices and social media services, educators can broadcast their opinions to the entire world any time of the day or night. This presentation helps teachers understand the potential impact of impetuous posts on their career, the limited protection offered by the First Amendment, and guidelines for safe social media use.

### IN THE ZOOM WHERE IT HAPPENED: ONLINE PRIVACY ISSUES FOR TEACHERS & STUDENTS

Remote learning tools have been growing in popularity over the last couple of decades but few anticipated that a global pandemic would make them the critical edtech tool of 2020. The plunge into full or even part-time online instruction has raised significant privacy concerns for both educators and students. This presentation explores those privacy issues and offers suggestions on how to strike the right balance between personal privacy and effective remote instruction.

### REMOTE LEARNING DOES NOT MEAN REMOTE ETHICS

The hurried embrace of remote learning tools has changed the relationship between teachers and students. Of necessity, educators have much more insight (literally) into the personal lives of their students. For professionals who are mandatory reporters in all 50 states, these insights can raise difficult ethical quandaries. Using the Model Code of Ethics for Educators as guidance, this presentation explores the topic of mandatory reporting in the remote learning environment, along with other potential ethical issues that might arise.

### CYBERTRAPS FOR ADMINISTRATORS AND SCHOOL BOARDS

Around the country, schools and school districts are seeing a rise in litigation and liability stemming from digital misconduct by educators and students. This presentation includes detailed discussions of policies and procedures that can help minimize legal exposure.
